- 1. Meeting called to order at 4:03 pm by Edward Walker.
- 2. Minutes approved unanimously
 - a. Approved with amendments
- 3. Dr. Gerber was recognized.
 - a. He distributed information about Ira Flatow's lecture.
 - b. Informed DHs that Honey would be contacting us about policies for suspending students for non-academic reasons.
 - i. Ed Walker asked if there is a university policy in place and Sheri Gravett said no.
 - c. Informed that search has begun for Chief Information Officer and named the members of the search committee. Chaired by Anthony Scheffler.
 - d. Informed that a search for Provost will begin concurrently and search firms are being examined.
 - e. An external firm is being hired to take a comprehensively look at IT for the benefit of the new CIO.
 - f. In response to a question from Ed Walker, the Interim Provost announced the possibility of a 2% merit raise but emphasized that nothing has been decided yet.
 - g. Linda Most inquired about the status of electronic graduation application.
- 4. Dr. Gravett was recognized.
 - a. Dr. Ross asked if a new major proposals that include other majors' courses, that the affected DHs be contacted as a matter of professional courtesy. Dr. Gravett agreed and noted that elements of such a process may be implemented by next fall.
 - b. Dr. Gerber suggested that the most important data for DHs might get critical data sent automatically in order to plan for sections.
 - c. Announced that curriculum changes may be made a little later than in the past but encouraged changes before April.
- 5. Dr. Ross gave an overview of a draft of the Department Head Professional Activity Report and asked for questions.
 - a. Approved unanimously except for one abstention.
 - b. Linda Most asked whether online majors have students applying for graduation without engaging in advising beforehand. Walker, Ross, and Martínez discussed their programs' procedures.
