**3) Communication with Administration**

a) Report from the President

- (1) Dr. Carvajal reported that the CAS review is completed and he thanked all who participated in any step in the process. The data is now being reviewed for future use by the university and the system.
- (2) Dr. Carvajal indicated that the President's and VPAA's office are in some disarray due to the renovations about to occur in both West Hall and Odum Library. The library space will become a fully integrated academic space for students which will include the Academic Support Center. Dr. Sheri Gravett and Dr. Michael Black are moving from their office suite in Nevins Hall to make room for the incoming Dean and will be located in the Provost's suite when it is completed. All of these offices are temporarily located on the 2<sup>nd</sup> floor of Powell Hall.
- (3) Dr. Carvajal reported that the USG Classification & Compensation kickoff will take place very soon and he will be attending for Valdosta State University.
- (4) Dr. Carvajal reported that summer 2018 enrollment is up approximately 10%. However, fall enrollment numbers are down (admits are up by 4-5%, but we are still suffering from retention issues with returning students).

The results of the survey indicated that more than half of respondents (students and employees) were opposed to the idea of a tiered parking model. student concerns and possible budget shortfalls). They hope to have more information to provide to the campus soon.
