Minutes of Tuesday September 17, 2019

1) Call to order

a) Chair Paul Leavy called the meeting to order at 9:02AM in the University Center, Cypress Room.

3) Communication with Administration

a) Dr. Carvajal reminded everyone the year, including the athletic year is off and running. Tonight is the home opener for the Volleyball team. The football team is 2-0 thus far. Please support our teams. Winning teams bring positive light to VSU. Dr. Carvajal was on ESPN touting our football program.

b) Enrollment numbers for fall have been erratic but should be up by 1% or so. Although not a great increase, we are one of the few USG schools up for fall. This, in addition to being up for spring and summer is good.

c) USG Strategic Plan being worked out. Dr. Carvajal is on the USG team. Our new VSU plan will align to the system plan. The regional forum being held at VSU to discuss the plan is rescheduled for Wednesday, October 25, 2019.

d) CVIOG study is done. We have only high level info so far. We are approximately \$4.5 million short on salaries. We should have more detail on the study at the October meeting. Not everyone should expect a raise but the university will enact a plan to address the salaries of those below in the best possible way. Dr. Carvajal reminded everyone that salaries have to come from continuing funds, not end of year one-time funds.

e) Dr. Black reported that the 5 year SACSCOC reaffirmation study is due in September 2020 and will begin in October 2019. The report will end up being approximately 600 pages with over 1000 pieces of evidence included. A new QEP will be included as part of it. A site visit will occur in March 2021.

f) Dr. Black reported that the 3rd cohort of the VSU Leadership Academy is open for applications until Monday, October 14, 2019. There is space for 36 participants this year. VSU is committed to professional development so consider applying.

4) Special Order of the Day

a) Keith Kupets, VSU Bookstore General Manager, reported on the continued success of the "Day One" program. This is where students get access to digital textbooks on day one of classes for the lowest possible cost. This program was piloted in LCOBA and CONHS very successfully and is about to be

implemented campus-wide. The program has saved students around \$250G to date. 95% of students in the program remained with it.

5) Approval of Minutes
